**1. KEY DATES:**

The Skate With Us National Contest (the “**Contest**”) is sponsored by Skate Canada (the “**Sponsor**”). The Contest begins on November 7, 2022 at 12:00:00 a.m. Eastern Time (“**ET**”) and ends on December 31, 2022 at 11:59:59 p.m. ET (the “**Contest Period**”).

**2. CATEGORIES:**

For the purposes of this Contest, there will be a total of three (3) categories (each, a “**Category**” and the “**Categories**”) as follows: (i) Skate Canada’s Got Talent; (ii) Skate With Us; and (iii) Club & Skating School.

**3. AGREEMENT TO BE LEGALLY BOUND BY RULES:**

By participating in this Contest, you are signifying your agreement that you (and your parent/legal guardian on your behalf if you are a Minor) have read and agree to be legally bound by these Official Rules and Regulations (the “**Rules**”).

**4. ELIGIBILITY:**

The Contest is not open to employees, representatives or agents (and those with whom such persons are domiciled, whether related or not) of the Sponsor, its associated and affiliated entities, prize suppliers, advertising/promotion agencies and any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfillment of the Contest (collectively with the Sponsor, the “**Contest Parties**”).

Skate Canada’s Got Talent and Skate With Us

NOTE TO MINORS: The Sponsor reserves the right, in its sole and absolute discretion, on a random audit basis to contact a Minor’s parent/legal guardian for the purposes of verifying their: (i) agreement to be legally bound by these Rules on the Minor’s behalf; (ii) consent to the Minor’s participation in this Contest; and/or (iii) consent to the collection, use and disclosure of the Minor’s personal information. Failure of a Minor’s parent/legal guardian to complete any such required verification to the complete satisfaction of the Sponsor within the time frame specified by the Sponsor may, in the sole and absolute discretion of the Sponsor, result in disqualification of the Minor.

Club & Skating School

The *Club & Skating School* Category is only open to skating clubs or skating schools that are located in Canada (a “**Club/School**”).

Any and all actions contemplated in these Rules on behalf of a Club/School must be completed by an authorized representative of the Club/School (each a “**Representative**”) who: (a) is a resident of Canada; (b) has reached the legal age of majority in their province or territory of residence; (c) resides in Canada during the Contest Period and at the time of participation, selection and fulfillment; (d) has the unencumbered authority and permission from the Club/School to participate in the Contest on behalf of the Club/School; and (e) has the unencumbered authority to legally bind the Club/School – including, without limitation, to these Rules and to any other required documentation as contemplated in these Rules. FOR GREATER CERTAINTY AND THE AVOIDANCE OF ANY DOUBT, THE REPRESENTATIVE IS NOT THE PARTICIPANT AND HAS NO RIGHT TO PERSONALLY CLAIM ANY PRIZE OR A PORTION THEREOF. THE PARTICIPANT IN THIS CATEGORY IS THE CLUB/SCHOOL. Sponsor reserves the right at any time, in its sole and absolute discretion, to disqualify any Club/School if Sponsor determines that allowing such Club/School to participate in (or continue to participate in) the Contest could bring Sponsor into public disrepute or in any way impact the good standing or reputation of Sponsor in the eyes of the general public. Sponsor’s decisions on all matters arising in this regard shall be final and binding without right of appeal.

**5. HOW TO SUBMIT A VIDEO:**

NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE OR OTHERWISE IMPACT YOUR CHANCES OF WINNING IN THIS CONTEST. Based on your selected Category, you must submit a YouTube hyperlink (the “**Link**”) to a video (a “**Video**”) that reflects the applicable theme (each, a “**Theme**”) as follows:

Skate Canada's Got Talent	Share your off-ice talents. This could be anything from musical talent, to dance skills, to magic – anything you want to show off!
Skate With Us	Share your personal stories and experiences with skating. Maybe it is to tell the concept behind this year's program, or how you learned a new skill, how you just mastered skating backwards or even how skating has become part of your identity. No matter if you skate alone, or with a team, or even if you just skate outdoors for fun, we want to hear why you love to skate!
Club & Skating Schools	Showcase something special about your Club/School. It could be something the Club/School does really well, a best-in-class practice, or something that is totally unique to the Club/School or something that the Club/School are particularly proud of.

All Videos must meet the following requirements:

- Video must be four (4) minutes or less in length;
- Video must be in English and/or French;
- Video file size must be no greater than 1 GB; and
- Video must comply with the YouTube Community Guidelines:

Neither Sponsor nor any of the other Released Parties will be responsible for the inability to view your Video for any reason – including, but not limited to, as a result of your settings or otherwise. Any Video that does not meet the specifications outlined above or that otherwise does not comply with these Rules or the Platform Rules is subject to disqualification in the sole and absolute discretion of Sponsor.

**The Contest is in no way sponsored, endorsed or administered by, or associated with YouTube. YouTube is hereby completely released of all liability by each participant in this Contest. Any questions, comments or complaints regarding the Contest must be directed to Sponsor and not to YouTube.**

To be eligible, all content and materials associated with your Form and Video (collectively, your “**Submission**”) must: (i) be submitted and received during the Contest Period; (ii) include all required components and materials noted above; and (iii) be in accordance with these Rules, including, but not limited to, the specific Submission Requirements listed below in Rule 8 (all as determined by Sponsor in its sole and absolute discretion).

## 6. SUBMISSION LIMIT AND CONDITIONS:

**There is a limit of one (1) Submission per participant, per Category.** If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any participant has attempted to use multiple names, multiple identities, multiple email addresses, any automated, macro, script, robotic or other system(s) or program(s), and/or any other means not in keeping with the Sponsor's interpretation of the letter and/or spirit of these Rules to enter or otherwise participate in or to disrupt this Contest; then they may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. The Contest Parties and each of their respective agents, employees, directors, successors, and assigns (collectively, the “**Released Parties**”) are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed, incomplete or incompatible Submissions (all of which are void).

## 7. VERIFICATION:

All Submissions and participants are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying any participant's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Submission and/or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the Sponsor's interpretation of the letter and spirit of these Rules. *\*Issued in the form of a cheque payable to the confirmed winner.*

The following conditions apply to all Prizes:

- None of the Released Parties makes any representation or offers any warranty, express or implied, as to the quality or fitness of any Prize awarded in connection with the Contest. To the fullest extent permitted by applicable law, each confirmed winner understands and acknowledges that they may not seek reimbursement or pursue any legal or equitable remedy from either the Sponsor or any of the other Released Parties should the applicable Prize fail to be fit for its purpose or is in any way unsatisfactory.
- Each Prize must be accepted as awarded and is not transferable or assignable (except as may be specifically permitted by Sponsor in its sole and absolute discretion).
- No substitutions are permitted, except at Sponsor's option.

##### **Stage One (Judging to select 3 Finalists per Category):**

In relation to each Category, a panel of judges (the “Judges”) appointed by the Sponsor will judge each eligible Submission on the basis of the following weighted criteria:

<b>Criteria</b>	<b>Weighting</b>
1. Creativity	30%
2. Understanding of the Theme	30%
3. Overall presentation	20%
4. Technical quality	20%
<b>Total Score</b>	<b>Maximum 100%</b>

Each Submission will be given a score (the “Score”) by the Judges. **Any Submission that does not achieve a threshold Score of 80% or higher (as determined by the Judges, in their sole and absolute discretion) will automatically be disqualified from further consideration.** Odds of being selected as an eligible Finalist depend on the number and calibre of eligible Submissions submitted and received in accordance with these Rules in each Category. In relation to each Category, the three (3) eligible participants associated with the top three (3) Scores (as determined by the Judges, in their sole and absolute discretion) will each be selected as an eligible Finalist. In the event of a tie between two or more eligible Submissions based on Score in a Category, the eligible participant – from amongst all such eligible Submission that are tied – with the highest score on Criteria 1 (followed in the event of a further tie by Criteria 2, then Criteria 3, then Criteria 4) will be selected as the eligible Finalist for the applicable Category. In the event of an exact tie based on all Criteria, a new panel of judges will be appointed by the Sponsor to break the tie in accordance with the preceding procedure. Judging is scheduled to be completed on or about January 6, 2023 (the “Finalist Selection Date”).

The Sponsor or its designated representative will make a minimum of three (3) attempts to contact each eligible Finalist (using the information provided on the Form) within five (5) business days of the Finalist Selection Date. If an eligible Finalist cannot be contacted as outlined above, or if there is a return of any notification as undeliverable; then they may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to be a Finalist) and the Sponsor reserves the right, in its sole and absolute discretion and time permitting, to select an alternate eligible Finalist from among the remaining eligible Submissions in the applicable Category (in which case the foregoing provisions of this section shall apply to such newly selected eligible Finalist).

NO ONE IS A FINALIST UNLESS AND UNTIL THE SPONSOR OFFICIALLY CONFIRMS THEM AS A FINALIST IN ACCORDANCE WITH THESE RULES. BEFORE BEING DECLARED AS A CONFIRMED FINALIST (each, a “Finalist”), each eligible Finalist will be required to sign (and have their parent or legal guardian sign if the eligible Finalist is a Minor) and return within five (5) business days of notification the Sponsor's declaration and release form, which (among other things): (i) confirms compliance with these Rules; (ii) releases the Sponsor and all of the other Released Parties from any and all liability in connection with this Contest, their participation therein; and (iii) agrees to the publication, reproduction and/or other use of their name, city and province/territory of residence, voice, statements about the Contest and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor in any manner whatsoever, including print, broadcast or the internet.

### **Stage Two (Public Voting to select Winners):**

In relation to each Category, each Finalist's Submission will be posted on the Website between January 14, 2023 at 12:00:00 a.m. ET and February 15, 2023 at 11:59:59 p.m. ET (the "**Voting Period**"). Members of the public will be able to visit the Website and vote (each, a "**Vote**" and collectively, the "**Votes**") for their favourite Finalist.

**VOTING LIMIT: There is a strict limit of one (1) Vote per person per day (defined as 12:00:00 a.m. ET to 11:59:59 p.m. ET).** For the avoidance of any doubt, this means that the same person cannot submit a Vote more than one (1) time per day during the Voting Period.

If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that attempts were made by anyone to: (i) submit more than one (1) Vote per person per day; (ii) use multiple names, multiple identities, multiple email addresses, any automated, macro, script, robotic or other system(s) or program(s), and/or any other means not in keeping with the Sponsor's interpretation of the letter and/or spirit of these Rules to submit Votes; (iii) engage in any form of systematic voting from the same computer/IP address; and/or (iv) engage in any form of proxy voting scheme; then it may result in the disqualification, in the sole and absolute discretion of the Sponsor, of the Votes, Submission and/or Finalist to which such Votes relate.

Any Votes determined by Sponsor, in its sole and absolute discretion, to be in violation of the Sponsor's interpretation of the letter and/or spirit of these Rules (including, without limitation, Votes that cannot be validated in accordance with these Rules to the complete satisfaction of Sponsor) are subject to disqualification in the sole and absolute discretion of the Sponsor.

All Votes are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof (in a form acceptable to the Sponsor): (i) for the purposes of verifying the eligibility and/or legitimacy of any Vote or other information entered (or purportedly entered) for the purposes of this Contest; and/or (ii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification of the applicable Vote(s) that cannot be verified to the complete satisfaction of the Sponsor.

**IMPORTANT NOTE:** Individuals may encourage others to vote for a Finalist (e.g. via various social media sites and platforms); however, no form of incentive, inducement (including, without limitation, reciprocal voting sites and/or services), prize or chance of receiving any incentive, inducement, or prize may be offered as part of such encouragement in furtherance of receiving such individual's Vote for any Finalist. In addition, proxy voting schemes (or anything reasonably resembling a proxy voting scheme, as determined by Sponsor in its sole and absolute discretion) are hereby expressly prohibited. Any individual determined by the Sponsor and/or its representative(s) to be engaging in any such behaviours and/or in violation of the Sponsor's interpretation of the letter and/or spirit of these Rules (all as determined in the sole and absolute discretion of the Sponsor) will be disqualified, and the corresponding Votes, Submission and/or Finalist is/are subject to disqualification in the sole and absolute discretion of the Sponsor.

**IMPORTANT NOTE:** JUST BECAUSE A NUMBER OF VOTES APPEARS ON A CONTEST LEADERBOARD OR OTHERWISE DOES NOT MEAN THAT THE FINALIST ASSOCIATED WITH THOSE VOTES IS OR WILL BE THE WINNER OF A PARTICULAR PRIZE. ANY OR ALL VOTES MAY BE VERIFIED BY THE SPONSOR IN ITS SOLE AND ABSOLUTE DISCRETION AT ANY TIME AND FOR ANY REASON. ANY SUCH PUBLIC DISPLAY OF VOTES IS FOR ENTERTAINMENT PROPOSES ONLY. ONLY THE SPONSOR CAN DEEM A PARTICIPANT TO BE AN ELIGIBLE WINNER.

On February 16, 2023 (the "**Selection Date**") in Ottawa, ON at approximately 12:00 p.m. ET, the Sponsor will tabulate the final number of eligible Votes submitted and received during the Voting Period in accordance with these Rules. In relation to each Category: (i) the Finalist that received the highest number of eligible Votes during the Voting Period (as determined by the Sponsor in its sole and absolute discretion) will be selected as the eligible winner of the First Prize for that Category; (ii) the Finalist that received the second highest number of eligible Votes during the Voting Period (as determined by the Sponsor in its sole and absolute discretion) will be selected as the eligible winner of the Second Prize for that Category; and (iii) the Finalist that received the third highest number of eligible Votes during the Voting Period (as determined by the Sponsor in its sole and absolute discretion) will be selected as the eligible winner of the Third Prize for that Category. Odds depend on the number of eligible Votes submitted and received during the Voting Period in accordance with these Rules.

NO ONE IS A WINNER UNLESS AND UNTIL THE SPONSOR OFFICIALLY CONFIRMS THEM AS THE WINNER IN ACCORDANCE WITH THESE RULES. BEFORE BEING DECLARED A CONFIRMED PRIZE WINNER (each, a “**Winner**”), each eligible Winner will be required to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Sponsor’s form of declaration and release); and (b) sign (and have their parent or legal guardian sign if the eligible Winner is a Minor) and return within five (5) business days of notification the Sponsor’s declaration and release form, which (among other things): (i) confirms continuing compliance with these Rules; (ii) acknowledges acceptance of the applicable Prize (as awarded); and (iii) releases the Sponsor and all of the other Released Parties from any and all liability in connection with the awarding and use/misuse of the applicable Prize or any portion thereof (including, but not limited to, any travel related thereto).

This Contest is subject to all applicable federal, provincial and municipal laws. The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all participants without right of appeal.

ANY INDIVIDUAL OR ENTITY DEEMED BY THE SPONSOR TO BE IN VIOLATION OF THE SPONSOR’S INTERPRETATION OF THE LETTER AND/OR SPIRIT OF THESE RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE SPONSOR AT ANY TIME.

The Released Parties will not be liable for: (i) any failure of the Website or any other website or platform during the Contest; (ii) any technical malfunction or other problems of any nature whatsoever, including, without limitation, those relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software; (iii) the failure of any Submission, Vote(s) and/or other information to be received, captured or recorded for any reason whatsoever, including, but not limited to, technical problems or traffic congestion on the internet or at any website; (iv) any injury or damage to a participant’s or any other person’s computer or other device related to or resulting from participating in the Contest; (v) anyone being incorrectly and/or mistakenly identified as a winner or eligible winner; and/or (vi) any combination of the above.
